### Representative Kane Encourages Residents to Shop Local Small Businesses November 25<sup>th</sup>-26<sup>th</sup> Small Business Weekend in the Commonwealth

(Boston) - State Representative Hannah Kane, (R-Shrewsbury), is reminding Massachusetts residents to shop at local businesses the Saturday and Sunday following Thanksgiving. Representative Kane co-sponsored a recently passed House Resolution establishing November 25<sup>th</sup> and 26<sup>th</sup> as Small Business Weekend in the Commonwealth.

The Resolution encourages residents to shop local and establishes Small Business Weekend to officially recognize the importance and positive impact small businesses and local entrepreneurs hold in communities across the Commonwealth. Residents of the Commonwealth are called upon to support their neighbors and local economy through making purchases at small and family-owned businesses on the weekend of November 25<sup>th</sup>.

"Small businesses are pillars of our communities and contribute to the very fabric and success of our towns. In turn, I am proud to support 'Main Street' through shopping locally and actively encouraging friends and neighbors in Shrewsbury and Westborough to do the same. Choosing to support family and small owned businesses is an investment in our Commonwealth's future," added Representative Kane. "For every \$100 spent locally, \$68 stays in our community, compared to only \$43 when spent at a chain store. It's a win-win for everyone. I hope others will join me in looking to their own backyard when shopping, dining, or searching for a gift this holiday season."

Representative Kane is a strong supporter of small business, having earned a spot in 2016 in the National Federation of Independent Business (NFIB) Massachusetts coveted "100% Club" for her perfect voting record on legislation that has a significant impact, either negative or positive, on the small business community in Massachusetts.

WHEREAS, THE COMMONWEALTH OF MASSACHUSETTS IS HOME TO HUNDREDS OF THOUSANDS OF THOSE SMALL BUSINESSES, AND FOR THAT ITS PEOPLE ARE RICHER, MORE FORTUNATE AND BETTER ABLE TO CARE FOR EACH OTHER, AND;

WHEREAS, NOWHERE IS THE VALUE OF SMALL BUSINESS HIGHER THAN IN THE CITIES AND TOWNS WHERE CIVIC ORGANIZATIONS, CHARITIES, RELIGIOUS ORGANIZATIONS AND RECREATIONAL ACTIVITIES FOR CHILDREN ARE PROUDLY AND UNRESERVEDLY SPONSORED BY THE MEN AND WOMEN IN LOCAL BUSINESS, AND;

WHEREAS, AT NO TIME HAS IT BEEN MORE IMORTANT FOR THE PEOPLE OF THE COMMONWEALTH TO RECOGNIZE THE VITAL CONTRIBUTIONS OF SMALL BUSINESSES TO THEIR COMMUNITIES AND SHOW THEIR RECIPROCAL SUPPORT BY SHOPPING LOCALLY; THEREFORE, BE IT

RESOLVED, THAT FOR THE PURPOSE OF REWARDING OUR SMALL BUSINESS OWNERS FOR THEIR GENEROSITY; AND FOR THE PURPOSE OF ACKNOWLEDING THEIR VITAL IMPORTANCE TO THE COMMONWEALTH OF MASSACHUSETTS; AND FOR THE PURPOSE OF ENCOURAGING SUCCESSIVE GENERATIONS OF CITIZENS TO CHASE THEIR DREAMS IN A NOBLE AND VALUABLE FASHION, THE HOUSE OF REPRESENTATIVES OF THE COMMONWEALTH OF MASSACHUSETTS HEREBY RECOGNIZE THE FIRST SATURDAY AND THE FIRST SUNDAY AFTER THE FOURTH THURSDAY IN NOVEMBER AS SMALL BUSINESS WEEKEND, BY WHICH ASSIGNMENT IT HOPES TO ENCOURAGE EVERY CITIZEN OF THE COMMONWEALTH TO SEEK THEIR GIFTS, SERVICES AND NECESSITIES FROM AMOUNG THEIR NEIGHBORS IN FREE ENTERPRISE; AND BE IT FURTHER
